

Our Corporations

Christian Horizons group of corporations comprises five companies. This structure ensures effective corporate governance, appropriate accountability to our members and donors, flexibility, stability, sustainability and undivided focus on service delivery. While each company has its own mandate and purpose, all are passionately committed to the vision, mission and values of Christian Horizons.

Christian Horizons International

Christian Horizons International was incorporated in 2011 to become the "umbrella" organization over the Christian Horizons group of companies. The remaining Christian Horizons companies, including Christian Horizons and Christian Horizons Global, are subsidiary corporations of Christian Horizons International.

Christian Horizons

Founded in 1965 as a nonprofit, faith-based charitable organization, Christian Horizons serves people with exceptional needs through a range of community-based programs including residential, community participation, employment and respite programs funded by Ontario's Ministry of Community and Social Services (MCSS) and Ministry of Children and Youth Services (MCYS), and Saskatchewan's Ministry of Social Services (MSS).

Christian Horizons (Canada)

Separately incorporated in 1977, Christian Horizons (Canada) is all of our camps and excursions, as well as our domestic work that is not funded directly by the government including fee for services, programs and vacations.

Christian Horizons Global

Christian Horizons vision of belonging extends to international communities and people at risk around the world through Christian Horizons Global. Through partnership with local organizations such as churches, schools and disability associations, we help through entrepreneurial education and opportunities, children's services and education, all toward the end of helping people belong to communities. Christian Horizons Global is funded entirely through the generous donations and partnerships of individuals, businesses, churches and foundations.

Xeorixs Homes

A non-profit organization incorporated in 1985, Xeorixs Homes leases homes to Christian Horizons and other developmental services agencies. Xeorixs Homes purchases properties and takes care of property maintenance and upkeep.

The Oneders of Technology

Have you ever tried to order food in a place where you didn't speak the language? What about asking for directions, or telling someone that you need something? What about trying to describe your hopes and dreams, frustrations or hurts, without knowing how to make the other person understand you?

For many people with a developmental disability, that's what life is like. Every single day.

Sam is a youth who can't use words to communicate. He lives at home with his parents, and all three make daily attempts to overcome the communication barrier. Like many of us, Sam gets frustrated when he's not understood.

Like so many communication issues today, there are a range of technological options to help bridge the gap. Sam's family initially tried choice board apps that required Sam to select folders, then files, to express himself. He found the system difficult to learn and clumsy to navigate. Good communication is easy and quick, and these systems weren't either of those things. The frustration continued.

When Christian Horizons introduced Sam and his family to Oneder (pronounced "wonder"), there was hope. Oneder uses real visual images, video modeling and text in a language the user can understand to teach fundamental life skills tailored to the specific needs of the individual user. The platform is visually easy to follow and use.

Sam was soon navigating independently to Oneder because he could easily set up his choices, be involved in selecting his activities and the order in which they would appear on his own visual schedule. Thirty-two employees within Christian Horizons have been trained to use Oneder in the past year, and in turn can train other Christian Horizons' employees. In the winter of 2016, Christian Horizons' employees trained Special Education Teachers from the Hamilton/Wentworth School board. Other organizations and colleges are interested in being trained to use Oneder, and interest is expected to grow as we promote Oneder at various conferences. Currently, 25 people supported by Christian Horizons are benefiting from Oneder.

When Sam goes grocery shopping, actual photos of the items he has purchased, in the store where he purchaces them, were added to one choice board. The items were ordered in how he found them in the store. Support staff would add their voice recording of the number of each item he needed to buy (e.g. "6 tomatoes"). Sam now shops independently without any verbal prompts from his support staff.

Sam likes to go to Popeye's after he completes his shopping. A choice board has been created on Sam's iPad with real pictures of the menu items he might choose to eat. A voice over has been added on each potential choice that when pressed by Sam tells the server what he wants. Sam is completely independent in ordering his meal! If Sam forgets to ask for ketchup the choice board prompts him as a reminder. The staff behind the counter at Popeye's now engage with Sam and not the staff who previously needed to support him in this activity. Functional independence, ability to communicate wants, needs and desires – helping people become as independent as possible...there's an app for that!



Purpose Creates Opportunities

How Rae Turned Folding Towels Into a Job

When someone finds purpose, no matter their age or circumstance, they can benefit the community they belong to. And so, at age 66, perhaps Rae wasn't ready to retire.

She told everyone she was. It was a sunny day in October when she moved from the Valley View Centre of Moose Jaw, her home of 57 years. Anyone who asked Rae about the move was told she was moving because she was retiring, and that was that. Had she wanted to, she could have lived comfortably and quietly in her new home at Wood Lily Drive

But Rae guickly decided that she had a mission in her new home: towel folding. The staff and her housemates never wanted for a folded and stacked towel, and Rae reveled in contributing to her small community.

Purpose is a powerful motivator, and soon Rae wanted to serve the larger community of Moose Jaw in the same way. Rae's support team rallied to find her a role in the community, helping her build a resume, connect with the local YMCA, and practice her job interview skills. Her drive to serve, along with her practice, paid off - she got the job right away.



Starting employment for the first time at age 66 is a hard thing to do. The towels need to be folded a certain way and stacked to a certain height, and the baskets never stop coming. Rae's first day of work was tiring but exciting, and she celebrated afterwards at a party attended by all the people supported by Christian Horizons in Moose Jaw, and the staff from the Wood Lily and Normandy Homes.

Rae's circle of celebrators has expanded since then. On April 15, 2016, Rae was a special guest at the Community's Contribution and Recognition Luncheon held by the local YMCA. The Mayor of Moose Jaw applauded the recipients for their contributions and expressed the City's gratitude and appreciation for the impact Rae and her peers make in our city.

Since moving to her home on Wood Lily, Rae has made a habit of surprising people: from the police staff who ran her criminal record check for employment to her own support team, Rae's desire and ability to contribute to her community as a gainfullyemployed citizen helps us to reimagine what life can look like for someone with a disability.

This year, generous sponsors supported 1300 children. This is the highest number of children actively sponsored since the launch of the program. We are blessed to have committed, passionate partners to pursue this work with.



Christian Horizons Global's ministry is funded entirely by donations and grants. To be good stewards of the funds that

people donate, we keep administrative costs as minimal as possible while still providing excellent administration and oversight to the work we do. In 2015-2016, 6% of donations were allocated to administration, 9% to fundraising, and 85% directly funded international programs.

Expanding our Horizons to the West

The energy was palpable at the houses on Wood Lily Drive and Normandy Drive in Moose Jaw, Saskatchewan as the people who had previously lived in the Valley View Centre institution settled into their new homes. New experiences and new friendships were plentiful.

Melvin helped to make beef barley soup and enjoyed playing "Garage Band" on his iPad. Guy enjoyed his new recliner and shared a smile full of mischief with each person that came into the room. Barbie looked up at objects that were not there and laughed when those supporting her glanced in the same direction. Sharon enjoyed an afternoon nap stretched out on the couch, where she could be aware of all the coming and goings. Rae sat at the kitchen table, taking in her surroundings, then decided she liked the place enough to put on her slippers and relax. Marjorie proudly took on the role of princess, sporting a very attractive tiara.

As Valley View Centre, which was home to 174 residents with development disabilities, started planning for its closure, a number of families indicated their desire to have their family member support by a faith-based agency as that family member moved into a local community.

Through research and meetings with the government of Saskatchewan, Christian Horizons accepted the invitation to become a service provider in the province. Two homes were opened in Moose Jaw in August 2015.

"Christian Horizons is very excited to assist the government of Saskatchewan in taking this very important step to close their last remaining institution for people with developmental disabilities. We are also delighted to be part of the lives of these eight people as we join the Moose Jaw community," said Allan Mills, Vice President, Community Services.

When Christian Horizons began to build partnerships with the local church community and other developmental service agencies and associations, the leadership from another faith-based agency in Saskatchewan took notice. Jordan Varey, Executive Director of Menno Homes of Sask. Inc., based in Waldheim Saskatchewan, was intrigued with the similarities between the two agencies. And, when Jordan attended the Christian Horizons Family Retreat in Ontario at the end of August 2015, he became excited about the possibility of something similar in his province.

Soon, conversations between Menno Homes Board of Directors and Christian Horizons turned into discussions around serious amalgamation. In April 2016, both boards approved an amalgamation between the two organizations and the transition plans began.

As Janet Nolan expressed, "We are thrilled to partner with the good folks of Menno Homes. With our shared faith and shared passion for service, we look forward to building communities of belonging together."





Another Christian Horizons Family Retreat Location

Galilee Bible Camp

Fresh, inviting snow marked the road to Camp Galilee. Building on our Family Retreat summer camp, seven families with and without exceptional needs came together at Camp Galilee near Ottawa, Ontario for a truly Canadian Winter Wonderland experience. The retreat was complete with snowman-building, snow-painting, snowmobiling, sledding, and a freshly-minted outdoor rink. One of the highlights of the week was a Canadiana-themed closing banquet, where campers wore hockey jerseys and toques or other red-and-white apparel, and had family photos taken in front of the large stone fireplace.

To simply rest and spend time with others is an important factor of belonging and a key ingredient of family retreats. Reflecting on her time, one mother observed that she "had an amazing time at the Christian Horizons Family Winter Retreat. In contrast to my everyday life it was so relaxing." Another described it as a "refreshing and fun time." David Hood, the speaker for the weekend, spoke powerfully on God's work in each person's life, not only in times of retreat and encouragement but in the tough times as well.

We are thankful for all of the volunteers, families, and partners that made Winter Wonderland the time of renewal and connection that it was. Communities are transformed as people head back from family retreats to make a difference where they live, work, and worship. We already have people signing up for next year and hope you'll join us January 13-15, 2017 for another weekend of wonders!

Ellie Nyholt was one of the recipients who was honoured at our Jubilee finale. She was nominated by Chantal Hunink, who wrote the following:





The committee consists of members of the Board of Directors who are not involved in the daily operations of the organization. The committee meets with management and the external auditors to review the audit findings, satisfy themselves that all audit responsibilities have been properly discharged, and review and recommend approval of the financial statements to the members of Christian Horizons.


