While each company has its own mandate, they each contribute to realizing our vision, mission and values.

 International was incorporated in 2011 to serve as the umbrella organization over the Christian Horizons group of companies. The remaining Christian Horizons companies are subsidiary corporations of Christian Horizons International.
 - Christian Horizons Founded in 1965 as a non-profit, faith-based charitable organization, Christian
 Horizons serves people with exceptional needs through a range of community-based programs
 including residential, community participation, employment and respite programs. Christian Horizons
 is funded by Ontario's Ministry of Community and Social Services (MCSS) and Ministry of Children
 and Youth Services (MCYS), and Saskatchewan's Ministry of Social Services (MSS).
 - Christian Horizons (Canada) Separately incorporated in 1977, Christian Horizons (Canada) includes our domestic work that is not funded directly by the government, including fee for services, leadership development and vacations.
 - Christian Horizons Global Christian Horizons vision of belonging extends to international communities and people at risk around the world through Christian Horizons Global. In partnership with local organizations like churches, schools, and disability associations, we help through entrepreneurial education and opportunities, children's services and inclusive education, all aimed towards helping build up communities so people of all abilities can experience belonging. Christian Horizons Global is entirely funded by generous donations from and partnerships with individuals, churches, businesses and foundations.
 - Xeorixs Homes A non-profit organization incorporated in 1985, Xeorixs Homes leases homes
 to Christian Horizons and other developmental services agencies. Xeorixs Homes purchases
 properties and takes care of property maintenance and upkeep.







Celebration on Ice

Take a moment to imagine it: the cool air of the rink on your face, the echoing sounds of playful laughter, the swish of blades on fresh ice as skaters zoom past. For the June "Celebration Skate" for Ben and Dylan, hosted by Christian Horizons at the University of Guelph, the event was so much more than its fun sights and sounds. Building communities of belonging was at the heart of the event where dozens of family and friends gathered to celebrate the accomplishments of these two young men.

Ben recently brought home a silver medal in floor hockey from the Special Olympics in Austria. He has always enjoyed playing sports and the silver medal run for him and Team Canada was truly memorable. "Austria was a cool experience," said Ben at the event, adding, "It was a great time for the team, and we played well." Head coach Mark Cullen attended the celebration and saw Ben as he had many times before: focused, determined, and a gifted athlete.

Dylan's recent accomplishments were celebrated as well. He was taking Christian Horizons' Culinary Training course in partnership with Humber College, learning food handling and preparation, kitchen safety, and a range of other skills that employers require. "I really enjoyed the program, and feel like I learned a lot. I'm glad I was able to be a part of the culinary course," Dylan said. Also in attendance were Lane Burman and his family, who have special appreciation for Dylan. He performed life-saving CPR near the train station in Kitchener after Lane suffered a heart attack. Dylan's quick thinking and CPR training made the difference between life and death for Lane.

As people gathered to cut the cake and dive into some delicious pizza, Maureen Madill, the Christian Horizons Program Manager who helped organize the event, commented, "It's great when we can all pause for a minute and recognize that these are really big accomplishments, and we've got some amazing people in our community. Celebrating made sense to us!"

Valuing People by **Valuing Choices**

Recognition and celebration are important pieces of how we value people at Christian Horizons. Yet at its best, valuing people is so much more – it means valuing their choices. With an over 50-year legacy of walking alongside people with disabilities, our organization has seen an amazing transformation in our services with more focus on individual choice. Jon's story with Christian Horizons is a shining example of that transformation, and how it makes a real difference in the lives of real people.



Ion first connected with Christian Horizons 12 years ago when he was 18. At the time, some personal challenges were blocking his goal of living on his own. But Jon's objective was always a part of his personalized plan with Christian Horizons.

"From day one, his objective was always to live independently," said Dennis Ivall, an Area Manager who worked closely with Jon. "Every personal plan kept that in mind, and he continued to journey towards additional independence."

Finally, after a few years of community-residence supports, lon accomplished his goal and is now living on his own. It's been an exciting time. Some of the challenges Jon had been facing were greatly reduced as his independence increased, and he's flourished personally. In fact, Jon is now employed and hoping to marry his long-term partner.

"Jon is much more independent, more confident, and a stronger self-advocate since moving out on his own. He says he's so much more fulfilled. He sees potential and aspires to continue to grow as a person," added Dennis

At Christian Horizons, our core values are more than statements on paper. They are woven into everything we do and how we engage with each person we work with. To us, valuing people means focusing with them on their goals and their choices. For Jon and the many other people like him we work with, the impact is incredible.

Building Belonging Through Loss

"There was so much joy in the room." That's what so many of the 240 guests said about the Ryan's Rays fundraising gala. The event was held in loving memory of Ryan Martz, a 7-year-old boy from Ancaster, Ontario who passed away suddenly in March 2016. The joy that Ryan brought to those ground him

away suddenly in March 2016. The joy that Ryan brought to those around him was felt by everyone who helped raise \$50,000 to support inclusive education in Asella, Ethiopia.

Diagnosed at birth with a rare congenital disorder, Ryan impacted all who met him with his bright blue eyes and contagious smile. His family and friends wanted his 'rays' to continue to shine and impact the world, leading to the incredible event. The New Revolution Choir kicked off the evening, which also featured a silent auction with goods from over 200 donors.

The sunshine that Ryan loved and carried with him echoes to the other side of the world to Horizons Academy in Asella. As a result of Ryan's Rays, plans to renovate, expand and properly equip inclusive education classrooms at the school are already underway. Students of all abilities will benefit from the improvements, and will be able to learn alongside each other in community.

Fostering belonging is at the heart of what we do at Christian Horizons. Ryan's Rays was a shining example of the kind of amazing impact inclusion can have. Ryan's community experienced it firsthand. Now, through inclusive education in Asella, belonging can be made real for children who never would have been able to go to school. That's what belonging can lead to, and it is indeed something to be joyful about.

Vic's story isn't just one of personal success. Vic belongs to his community in an integral way, where his skills and passion are needed. As one of Vic's customers says, "There's just so much comfort in knowing that [my pet] is ok, that he's being cared for. I know Vic does a great job, and I don't know what I'd do without him."

Serving others is a core value at Christian Horizons, and it's contagious. We've seen time and time again that the people who use our services often serve others in return. Like Vic, people engaged with Christian Horizons have added so much to their communities. That's why this value is so important to us – it's a starting point, a catalyst, to building communities of belonging from the ground up.

With the opportunity to learn before her, Senait applied herself and progressed quickly through her education. Recently, she graduated from University. Even more, she's set to become an educator herself,

with a focus on teaching young people with disabilities.





RESPONSIBILITY OF FINANCIAL REPORTING

Board of Directors – The financial statements for the year ended March 31, 2017 for Christian Horizons, Christian Horizons (Canada), Christian Horizons Global and Xeorixs Homes have been approved by their respective Board of Directors, which has the overall responsibility for their content.

Management – The financial statements have been prepared by the management team, which is responsible for the integrity, objectivity, and reliability of the information contained therein. The financial statements have been prepared in accordance with Canadian Accounting Standards for not-forprofit organizations, and management has made best estimates where deemed appropriate.

Audit Committee – The audit committee oversees management's responsibility for the financial reporting and internal control systems. The committee consists of members of the Board of Directors who are not involved in the daily operations of the organization. The committee meets with management and the external auditors to review the audit findings, satisfy themselves that all audit responsibilities have been properly discharged, and review and recommend approval of the financial statements to the members of Christian Horizons.

External Auditors – For the year ending March 31, 2017, KPMG LLP was appointed by the members to audit the organization's financial statements [Christian Horizons, Christian Horizons (Canada), Christian Horizons Global and Xeorixs Homes]. A Summarized Combined Financial Statement Prepared by Management is presented on page 12.
